FIRST AMENDMENT

NEIGHBORHOOD DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR LA PRIVADA AT VERDE SANTA FE

This First Amendment to the Neighborhood Declaration of Covenants, Conditions, Restrictions and Easements for La Privada at Verde Santa Fe (the "Declaration") is made and effective as of the date of its recording.

RECITALS

AMENDMENT

NOW, THEREFORE, the following Section (to be known as Section 3.35) is hereby added to the Declaration:

3.35 Leasing. All leases must be in writing and shall be for a term of no less than thirty (30) days (unless the lease is for the calendar month of February, in which the lease term may be 28 or 29 days as applicable). No Owner may lease less than his/her entire Lot or Residential Unit. An Owner shall notify the Association of any lease and shall provide the Association with the tenant information as allowed by A.R.S. 33-1806.01, as may be amended from time to time. The Owner shall be liable for any violation of the Declaration or the Association Rules by the tenant(s) or any other persons residing in the Residential Unit.
